It was reported that a trailer caught fire as a result of a tire blow out and wheel fire. The trailer was carrying 1440 house hold, propane cylinders some of which have ruptured due to the fire. Debris and liquids from the destroyed truck and trailer impacted the roadway and nearby soils. The roadway was cleared with an excavator and sweeper. Excavation of the soils is to occur in the near future.
