DRIVER, WAS UNLOADING INTO A 100000 GAL. JET FUEL TANK AT SALT LAKE CITY AIR PORT. HE HAD UNLOADED INTO SAME TANK ON PREVIOUS LOAD AND THOUGHT THE LOAD WOULD FIT , AFTER UNLOADING (PUMPING INTO 100,000 GAL. TANK) FOR APPRO. 20 MINS. DRIVER WALKED AROUND OTHER SIDE OF TANK, SAW FUEL COMING FROM TOP OF 100,00 GAL TANK, HE RAN BACK AND SHUT OFF THE PUMP AND NOTIFIED THE HUDSON GENERAL PEOPLE AND THE AIR PORT AUTHORITIES CLEAN UP WAS STARTED IMMEDIATELY. 2100 GALLONS OF FUEL WAS RECOVERED BY WARD TRANSPORT, INC. & 1900 GALLONS WAS RECOVERED BY INDIAN OIL, A RECOVERY COMPANY THE AMOUNT OF THE SPILL WAS 3,000 TO 3,500 GALLONS ALL FUEL WAS CONTAINED, NONE INTO ANY WATER WAYS. NO INJURIES, NO FIRE (DRIVER TERMINATED FOR NOT FOLLOWING PROCEDURES) ACTION TAKEN TO PREVENT FUTURE INCIDENTS, MANDATORY THAT DRIVERS FOLLOW NOT ONLY OUR COMPANY RULES AND REGULATIONS REGARDING UNLOADING PROCEDURES. AS WELL AS THE FUEL CONTRACTORS RULES AND PROCEDURES OF UNLOADING AT THIS SITE.
