Describe:

The driver of a tractor and Portable tank lost control due the passenger side steering wheel went off the roadway to the soft shoulder causing the unit to roll to its right side. Hazmat was released from the pressure relief valve due to over-pressurization to the tank body and a 1'x 1' area of the soil shoulder. There was no reported damage to the relief valve. A cleanup contractor was dispatched to remediate the release. The incident was reported to the NRC because local police and fire advised that the roadway was a main road and that a nearby elementary school issued a shelter in place. Our Reference 45196.
