Unit was traveling North on I-65. When he topped a hill, traffic was stopped. Driver applied the brakes and vehicle began to hydroplane. He could not get stopped in time. To avoid hitting the other vehicles, he veered into the median. The unit overturned. The dome lids on the cargo tank began leaking diesel fuel. Cullman County Hazmat responded to the scene and began the containment process. SWS environmental was also dispatched to the scene for remediation purposes. ADEM sent an official to the scene to oversee the process. The dome lids leaked for approximately 2 hours.
