COASTAL UNIT MOVED ONTO SHOULDER BUT WAS STRUCK BY OTHER VEHICLE ON THE LEFT SIDE OF THE TRUCK AND THE LEFT FRONT OF THE TRAILER. THE LEFT FRONT OF COASTAL'S TRAILER WAS PUNCTURED CAUSING ABOUT 1,300 GALLONS OF DIESEL TO SPILL.
