WHILE CARS WERE BEING MOVED WITHOUT BENEFIT OF MOTIVE POWER, TANK CARS "GOT AWAY" FROM PERSONNEL MOVING THEM. THE CARS ROLLED DOWN A GRADE STRIKING THE APPLIED DERAIL. CARS DERAILED AND LANDED AGAINST A BANK, ON THEIR SIDES. TGAX 131217 LOST APPROXIMATELY 500 GALS OF PRODUCT; TGAX131311 LOST NONE BECAUSE IT HAD LESS THAN 50 PERCENT PRODUCT REMAINING. FIRE DEPARTMENT PERSONNEL TIGHTENED MANWAY BOLTS AND STOPPED LEAK. 2 FIREFIGHTERS, 1 POLICE OFFICER, 2 SPECTATORS TREATED FOR MINOR SKIN OR THROAT IRRITATION; 1 BIDS EMPLOYEE HOSPITALIZED FOR BROKEN ARM AND LEG WHEN HE JUMPED OVER FIRE FROM CARS HE WAS TRYING TO BRAKE.
