Driver was traveling on US-23 when he noticed smoke coming from the rear of the unit. Driver stopped and investigated. The tire on the trailer was on fire. Driver called 911 and attempted to put out the fire. The automatic closing device worked as designed. As the fire continued to burn, the automatic closing device received external damage, causing a small product release to the air. We estimated 10 liquid gallons. Once the fire was extinguished, the product was transferred to another trailer and the road was reopened.
