ON 5/7/93, UTLX 11222 FOR LCI, CONTAINING HYDROFLUOSILIC ACID WAS SWITCHED INTO THE LOCUST POINT FACILITY. AT 8:30AM ON 5/10/93 RAILCAR WAS OBSERVED LEAKING. A CONTAINMENT DEVICE WAS IMMEDIATELY PLACED UNDER THE CAR. THE AREA WAS ALSO BLANKETED WITH SODA ASH. ALL LOCAL AUTHORITIES WERE CONTACTED, A HAZMAT CLEAN UP CORPORATION AND CSXT HAZARDOUS MATERIALS MANAGER. IT WAS DETERMINED A BELLY HARNESS SHOULD BE CONSTRUCTED TO STOP THE LEAK AND THE MATERIAL TO BE TRANSFERRED OUT OF THE CAR. THE MATERIAL WAS TRANSFERRED INTO PARTIALLY EMPTY CAR ON SITE GATX 38750 AND AMERICAN TANK TRAILER 5010. APPROX. 178 GALLONS WERE RELEASED, A MAJORITY OF WHICH WAS CONTAINED AND NEUTRALIZED. LCI THE SHIPPER HAD APPLIED FOR AN EXEMPTION TO TRANSPORT THE CAR VIA THE RAIL AND WERE DENIED THEY ARE CURRENTLY AWAITING AND EXEMPTION TO TRANSPORT THE CAR VIA GONDOLA CAR.
