DRIVER CALLED 911. LOCAL FIRE DEPT. ARRIVED & EXTINGUISHED FIRE INSIDE TRAILER. NO HAZARDOUS WASTE MATERIAL WAS SPILLED BUT FUTURE ENVIRONMENTAL SERVICES WAS CALLED TO CLEAN WATER THAT WAS USED TO SUPPRESS THE FIRE. TRACTOR/TRAILER WERE TAKEN TO FUTURE ENVIR.
