Describe:

OUR DRIVER WAS UNLOADING 7500 GALLONS OF LOW SULFUR DIESEL. WHILE UNLOADING HE OVERFILLED THE ABOVEGROUND TANK, SPILLING APPROXIMATELY 100-120 GALLONS OF FUEL. THIS INCIDENT WAS OUR DRIVERS ERROR. PRIOR TO UNLOADING THE DRIVER IS TO MAKE SURE THAT THE TANK WILL HAVE ROOM FOR THE PRODUCT HE IS UNLOADING. THIS DRIVER DID NOT ASSURE HIMSELF THAT THE TANK WOULD HOLD THE LOAD OF FUEL. THIS POLICY IS STATED IN OUR DRIVER HANDBOOK AND THIS PROCEDURE IS TAUGHT TO EACH DRIVER WHILE IN TRAINING THAT ALL DRIVERS MUST MAKE SURE THAT ANY TANK WHETHER UNDERGROUND OR ABOVE GROUND WILL HOLD THE PRODUCT BEING DELIVERED. THEY MUST MEASURE THE TANK AND ASSURE THEMSELVES THAT THE PRODUCT WILL FIT. IF THEY ARE UNABLE TO VERIFY THAT THE PRODUCT WON'T FIT, THEY ARE NOT TO ULOAD UNTIL THEY ARE ABLE TO MAKE SURE THE TANK WILL HOLD THE PRODUCT. BECAUSE OF THIS INCIDENT, WE HAVE SENT A MEMO TO ALL DRIVERS TO REMIND THEM THAT THEY MUST MAKE SURE THAT THE TANKS ARE UNLOADING INTO CAN HOLD THE PRODUCT. THIS ITEM OF UNLOADING AND LOADING IS COVER UNDER OUR DRIVERS MANUAL THAT EACH DRIVER RECEIVES AT THE TIME OF HIRING AND ALSO THIS PROCEDURE IS TAUGHT TO EACH NEW DRIVER BY THE TRAINING DRIVER. CLEAR HARBORS WAS CALLED TO CLEAN UP SPILL. BOOMS & ABSORBENT PADS WERE PUT DOWN. SITE WAS CLEANED UP.
