OUR DRIVER WAS TRAVELING ON MD RT. 702 ENTERING THE EXIT RAMP ONTO EASTERN AVE., WHEN HE LOST CONTROL OF THE UNIT CAUSING IT TO OVERTURN RESULTING IN A LOSS OF CARGO APPROX. 1300 GALLONS OF JP-4. A PORTION OF RT. 702 WAS CLOSED TO TRAFFIC & SEVERAL HOMES WERE EVACUATED FOR PRECAUTIONARY MEASURES. APPROX. 1,000 GALLONS ENTERED A NEARBY STREAM WHICH LEADS INTO MIDDLE RIVER. CLEAN UP INVOLVED SETTING UP BOOMS AND FLUSHING WITH 6,000 GALLONS OF WATER. MATERIAL WAS PICKED UP AT BOOM. NOTE: MATERIAL DID NOT GET INTO MIDDLE RIVER. AUTHORITIES PRESENT: MD.
