THE OCALA, FL POLICE DEPT. REPORTED A RAILCAR IN A SOUTHBOUND TRAIN HAD A MISSING WHEEL & SPARKS FLYING. S60317 WAS INSPECTED & FOUND 5 CARS DERAILED; 3 EMPTY COVERED HOPPER & 2 LOADED TANK CARS. PTLX 126010, LD PETROLEUM OIL, DERAILED UPRIGHT, INLINE, JUST WHEELS OFF WITH NO PRODUCT LEAKAGE. PTLX 126005, LD PETROLEUM OIL, DERAILED ON ITS SIDE & LEAKING FROM THE MANWAY COVER. LOCAL PD & FD ON SCENE. THE FIRE DEPT. ATTEMPTED TO TIGHTEN MANWAY SWING BOLTS ON PTLX 126005; SLOWED RATE OF LEAKAGE. RESPONDED ENVIRONMENTAL CONTRACTOR TO CONDUCT CLEANUP. SHIPPER WAS NOTIFIED VIA CHEMTREC. STATE & FEDERAL AGENCIES NOTIFIED. CSXT HAZMAT ON SCENE. THE FD PLACED CONTAINMENT POOL UNDER LEAKING MANWAY ON PTLX 126005. ESTIMATE 200 GALLONS OF PETROLEUM OIL SPILLED ON THE GROUND OVER AREA OF APPROX 25 - 30FT LONG BY 5-8FT WIDE. PTLX 126010 RERAILED AT 0926HRS. PTLX 126005 WAS ROLLED UPRIGHT AT 1020HRS & LEAKAGE WAS STOPPED. PTLX 126005 CAN NOT BE RERAILED DUE TO DAMAGE TO DRAFT GEAR. PRODUCT MUST BE TRANSLOADED INTO TRUCKS FOR DELIVERY TO THE CONSIGNEE. PRODUCT TRANSFER & TRANSPORT TO CONSIGNEE COMPLETE ON 7/19. PRODUCT IMPACTED SOILS WERE EXCAVATED & PLACED IN ROLLOFF CONTAINER. PTLX 126005 WAS CLEANED & PURGED ON 7/20.
