RELEASE OF PRODUCT DUE TO FAULTY/NON-FUNCTIONING GAUGES ON TWO UNLOADING TANKS AT THE CONSIGNEE SITE. DRIVER BEGAN THE UNLOADING PROCESS AT FIRST TANK AND DUE TO AN UNREADABLE GAUGE APPROXIMATELY 30 GALLONS OVERFLOWED IN THE CONTAINMENT AREA. DRIVER WAS THEN DIRECTED TO ANOTHER TANK UNDER THE DIRECTION OF AN CONSIGNEE EMPLOYEE. THE NEW TANK HAD A SIGN ON THE GAUGE INDICATING THE GAUGE WAS OPERATIONAL, HOWEVER APPROXIMATELY 100 GALLONS OVERFLOWED FROM THE SECOND TANK. ALL OF THE PRODUCT WAS CONTAINED IN THE CONSIGNEE CONTAINMENT AREA. NO INJURIES OCCURRED. NO ADDITIONAL ASSISTANCE WAS REQUIRED.
