Describe:

At 1739ET, XPO notified ERTS of a cargo release located at terminal XWB. It was reported that an unknown amount of Acid N released from (1) 275-gallon poly tote due to puncture from the metal part of a strap. The release is impacting the trailer floor, is releasing heavily, and starting to leak out onto the concrete yard. Terminal personnel are putting speedy dry around the release to try to contain it. The caller reported the tote is punctured on the side about 4" from the bottom and will be empty by the time a contractor arrives on site. Contractors recovered Acid N product, impacted absorbents, pads, and plastic in (18) 55-gallon poly drums. The drums were staged onsite at the terminal for personnel to handle.
