UPON ARRIVAL BACK AT THE CONSIGNEE HE OBSERVED PRODUCT OVERFLOWING OUT OF THE PIT. HE STARTED UP THE PUMP TO STOP THE BACKFLOW FROM THE STORAGE TANK. INVESTIGATION REVEALS THAT THE CHECK VALVE IN THE TRANSFER LINE FAILED AND ALLOWED PRODUCT TO SIPHON BACK INTO PIT. CONSIGNEE CONTAINED AND CLEANED UP AREA.
