Describe:

According to the information obtained, the following occurred. While attempting to make a left turn, the tractor-tanker unit rolled over. As a result of the incident an estimated 58 nearby businesses were evacuated and Illinois Route 12 was closed. The local Police and Fire Departments responded to assess the site. Clean Harbors Environmental Services, Inc. of Chicago, Illinois was dispatched to perform any necessary cleanup and assist with product transfer. Clean Harbors Environmental Services, Inc. inspected the area and discovered a release of approximately one gallon of product as well as one gallon of motor oil and one gallons of diesel fuel. Clean Harbors Environmental Services, Inc. applied absorbent material to contain the free liquid. Clean Harbors Environmental Services, Inc. transferred the product from the tanker into a new tanker. Upon completion of product transfer, the tractor-tanker unit was up-righted. No injuries or exposures were reported. The Material Safety Data Sheet was requested and received.
