WHILE TRAVELING ON I74 NEAR GALESBURG IL MG DRIVER LOST CONTROL OF HIS VEHICLE AND STRUCK GUARD RAIL. VEHICLE THEN LEFT THE ROAD BERM AND TRAVELED UP AN EMBANKMENT AND OVERTURNED. CARGO TANK STRUCK A TREE CAUSING THE VESSEL TO RUPTURE ALLOWING THE LOAD OF LIQUID OXYGEN TO SPILL. NATURE OF THE COMMODITY DISPERSED ITSELF BACK INTO THE ATMOSPHERE. FUEL TANK FOR THE TRAILER WHILE OVERTURNED ALLOWED FOR DIESEL FUEL TO LEAK ONTO GROUND. NO WATERWAYS WERE COMPROMISED AND DIESEL FUEL SPILL WAS CONTAINED TO A LIMITED AREA. DIESEL FUEL WAS NOT A SHIPMENT COMMODITY ASSOCIATED WITH THE CARGO.
