TRACTOR/TRAILER BECAME UNCOUPLED WHILE IN TRANSIT CAUSING CARGO TANK TO HIT THE GROUND ON ITS NOSE. UPON IMPACT THE FRONT OF THE TRAILER BUCKLED AND SPLIT THE FRONT RIGHT BOTTOM WELDED SEAM, SPILLING 2500 GALLONS OF JP-8 AT AN EST RATE OF 25 TO 30 GALLONS PER MINUTE. ROSWELL, NM FIRE AND STREET DEPARTMENT RESPONDED AND DYKED AREA TO CONTAIN THE SPILLAGE. THE CONTAINED SPILLAGE WAS PUMPED INTO A VACUUM TRUCK AND TRANSPORTED TO THE REFINERY. THE CONTAMINATED SAND WAS TRANSPORTED TO AN APPROVED LAND FILL. THE INCIDENT WAS CAUSED BY A FAULTY LOCKING MECHANISM IN THE 5TH WHEEL. ALL COMPANY TRACTORS ARE BEING INSPECTED AT THIS TIME FOR THIS CONDITION.
