THE PRODUCT THAT ENDED UP IN THE SOIL IS BEING EVALUATED FOR REMEDIAL ACTION. THE HOLE IN THE CAR WAS OBLONG ABOUT THE SIZE OF A FOOTBALL (SEE ATTACHED PHOTO).
