Truck owner by Davidson Surface Air was traveling on I-70 EB at MM 19. Another tractor trailer changed lanes in front of the Davidson truck causing the driver to slam on his brakes. The load shifted due to the sudden deceleration causing one of the totes of Phosphoric Acid to be punctured and leak.

Approximately 150-200 gallons of the product leaked into the trailer and onto the ground under the trailer. The local fire department and hazmat unit were called to the scene. The local fire department set up containment pools to catch the leaking material.

Summit Environmental came to the scene and completed the remediation on site.
