Tankcar UTLX 970024, hydrogen fluoride anhydrous residue, was reported to possibly be releasing vapor in Track 303, in Neff Yard. Two carmen reported a chemical odor while adjacent to UTLX 970024 (hydrogen fluoride anhydrous residue) and PTLX 223977 (ethyl mercaptan). Inspection of both cars found no release of product and the cars were secure.
