Describe:

First coast terminals notified terminal operations on 8/10 @ 11:05 am that the ISO tank LNDU8402006 / VSSL001502899 was venting and releasing fumes. The commodity was UN2187 Carbon Dioxide. The area was closed off from personnel and traffic. The terminal notified customer service and hazardous specialists to have the customer remove the tank from the facility. On Wednesday 8/12, the tank was still not removed from the terminal, and the situation had become more severe as it was actively releasing vapors. We then contacted the fire department, which managed to secure the valve and stop the leakage. The USCG was then contacted to approve the tank for transport over the road. The trucker came on 8/12 @ 6:17 pm and the tank was removed from the terminal.
