THE DRIVER WAS TRAVELING WEST ON OK 33 AND HAD JUST CROSSED OVER THE CIMARRON RIVER BRIDGE, ONE MILE EAST OF COYLE, OK. UPON EXITING THE BRIDGE HEADED WEST, THERE IS A S CURVE. THE DRIVER ALLOWED HIS TRAILER TAMDEMS OFF THE ROAD. HE TRIED TO CORRECT, AND OVER TURNED THE UNIT. THE TRAILER WAS SLIDING ON ITS SIDE ON THE ROADWAY. THE SKIDDING ACTION CAUSED THE ALUMINUM TO WEAR THRU ALLOWING THE DIESEL TO LEAK OUT. THE SPILL WAS CONTAINED IN THE SAND ON THE SIDE OF THE ROAD. THE CONTAMINATED SAND WAS PICKED UP AND TRANSPORTED TO AN AUTHORIZED LANDFILL AT STILLWATER, OK.
