WHILE PROCEEDING ON THE ON RAMP TO EXIT 111 EASTBOUND FROM INTERSTATE 20 TO INTERSTATE 26 IN COLUMBIA, SOUTH CAROLINA, THE SLAY TRANSPORTATION TRACTOR-TANKER UNIT ROLLED-OVER. APPROXIMATELY, THREE HUNDRED GALLONS OF FREE PRODUCT WERE RELEASED ONTO THE ASPHALT AND SOIL. THE LEXINGTON COUNTY FIRE DEPARTMENT AND SOUTH CAROLINA STATE POLICE RESPONDED TO THE SCENE TO ASSESS THE SITE. NU WAY ENVIRONMENTAL OF COLUMBIA, SOUTH CAROLINA WAS CONTACTED TO PERFORM THE CLEANUP. NU WAY ENVIRONMENTAL PRESSURE WASHED THE AFFECTED ASPHALT AND EXCAVATED THE CONTAMINATED SOIL. NU WAY ENVIRONMENTAL WILL COORDINATE DISPOSAL OF ALL WASTE GENERATED. NO INJURIES OR EXPOSURES WERE REPORTED. ALL STATE AND LOCAL REGULATORY AGENCIES WERE NOTIFIED.
