DRIVER WAS OVERCOME BY FUMES AND 911 WAS CALLED AND DRIVER TAKEN TO ST. VINCENT HEALTH CENTER FOR TREATMENT AND WAS RELEASED 10/16/90. DRIVER HAD BREATHING DIFFICULTY AND HIS ESOPHAGUS BURNED. DRIVER RETURNED TO HIS HOME TOWN HOSPITAL ON 10/18/90 SINCE HIS THROAT STILL HURT. SPILL WAS CONTAINED AND THE LEAKER DRUM WAS PUT INTO RECOVERY DRUM.
