IN THE COURSE OF DOING SO, THE CONNECTION BETWEEN THE HOSE ADAPTOR AND THE STORAGE TANK BECAME COMPROMISED AND APPROXIMATELY 150 GALLONS OF DIESEL FUEL WAS RELEASED. VEOLIA ENVIRONMENTAL RESPONDED TO THE SCENE AND HANDLED THE REMEDIATION. NO FURTHER ENVIRONMENTAL IMPACT IS ANTICIPATED.
