VEHICLE HAD BEEN INVOLVED IN A MAJOR VEHICULAR ACCIDENT. DURING RECOVERY OPERATION, THE FRONT OF THE TRAILER THAT THE MC330 TANK WAS MOUNTED ON WAS BEING LIFTED. ALTHOUGH THE TANK WAS NOT DAMAGED DURING ACCIDENT, WRECKER'S BOOM BUCKLED UNDER THE LOAD OF LIFT, CAUSING TRAILER TO DROP SHORT DISTANCE. WHEN THIS OCCURRED, LANDING LEG OF TRAILER CAME INTO CONTACT WITH "WET LINE" COMING FROM TANK AND APPLIED PRESSURE. FLANGE IN "WET LINE" RELEASED SMALL AMOUNT OF SULFUR DIOXIDE THAT WAS IN LINE. WRECKER DRIVER MICHAEL GRAHAM INHALED THE GAS AND WAS OVERCOME, REQUIRING HOSPITALIZATION.
