THE SHIPPER WAS LOADING PRODUCT INTO AN ISO CONTAINER. THERE WAS AN APPARENT MALFUNCTION DURING THE LOADING PROCESS AND THE SHIPPER'S EQUIPMENT FAILED TO SHUT OFF ONCE THE TANK WAS FULL TO CAPACITY. AS A RESULT, THERE WAS A PRODUCT RELEASE FROM THE TOP OF THE TANK DUE TO OVERFILLING. THE RELEASE PRODUCT (APPROX. 800-1000 GALLONS) WAS CONTAINED WITHIN THE LOADING CONTAINMENT AREA. DRY ABSORBENT WAS PLACED OVER THE RELEASED PRODUCT ON THE GROUND. THE RELEASED PRODUCT WAS CLEANED-UP AND PLACED IN BARRELS BY THE CONSIGNEE, AND DISPOSED OF ACCORDING TO THEIR POLICIES.
