THE UNIT WAS WET BOUND ON US 12 IN IDAHO ABOUT 1/4 MILE EAST OF MM 164 WHEN THE DRIVER ENTERED A LEFT HAND CURVE. ABOUT 3/4 WAY THROUGH THE CURVE THE SECOND TRAILER WENT INTO THE RIGHT HAND DITCH AND UPSET, HITTING A ROCK WHICH RIPPED THE RIGHT SIDE OF THE TRAILER OPEN. WHEN THE UNIT CAME TO STOP PRODUCT WAS SPILLING OUT OF THE TRAILER AT THE RATE OF 10 GALLONS PER MINUTE. THE ODAHO TRANSPORTATION DEPT. MAINTENANCE AND FOREST SERVICE SERVICE PERSONEL SHOWED UP AT THE SCENE AND BUILT DIKES TO CONTAIN THE SPILL. AN ENVIRONMENTAL CONTRACTOR, ENVIROCON, INC. FROM MISSOULA WAS CONTACTED AND SUPERVISED THE CLEAN-UP OPERATION. THE TRAILER WAS HAULING 2750 GALLONS OF PRODUCT. THERE WAS ABOUT 150 TO 200 GALLONS LEFT IN THE TRAILER. A VACUUM TRUCK RECOVERED FROM 2400 TO 2500 GALLONS OF PRODUCT. APPROXIMATELY 50 YARDS OF SOIL WAS EXCAVATED AND THE AREA TESTED AND THEN BACKFILLED WITH FRESH SOIL.
