THE LEAD TRAILER TRAVELED ON THE SHOULDER OF THE ROAD MISSING THE GUARD RAIL, HOWEVER, THE SECOND TRAILER RODE UP THE GUARD RAIL FLIPPING ON ITS SIDE. THE GUARD RAIL STRUCK THE PIPING UNDERNEATH THE TRAILER AND CAUSED THE PRODUCT TO SPILL ON THE GROUND. THE CONTAMINATION OF THE SOIL IS BEING EXCAVATED AND DISPOSED OF AT A LANDFILL. CLEAN SOIL WILL BE BACK FILLED INTO THE AREA.
