LOADING ACTIVITIES WERE IMMEDIATELY SHUTDOWN AND THE SPILL WAS CONTAINED IN THE PARKING LOT WITH ABSORBENT BOOMS AND PILLOWS. PETRO CHEM RECOVERY SERVICES WAS CALLED TO THE SCENE AND THEY CLEANED UP THE SPILL WITH A VACUUM TRUCK AND ABSORBENT MATERIALS. DRIVERS HAVE BEEN INSTRUCTED TO PREVENT FUTURE SUCH SPILLS.
