A CUT OF CARS BEING SWITCHED IN RAIL YARD WERE ROLLED INTO STANDING TANK CARS TO MAKE A COUPLER JOINT, BUT COUPLERS BY-PASSED BETWEEN UTLX 203467 & TEIX 30054 PUNCTURING THE A-END TANK HEAD OF TEIX 30054 RELEASING PRODUCT. A FIRE ENSURED, FULLY ENGULFING TEIX 30054 & THE B-END OF UTLX 203467. AN ESTIMATED 95% OF PRODUCT BURNED IN THIS FIRE WITH THE REMAINING 5% IMPACTING SURROUNDING GROUND AREA IN RAIL YARD. IMPACTED SOIL WAS EXCAVATED FOR DISPOSAL. THE FIREBALL SPALLED CONCRETE PILLARS & THE UNDERSIDE OF STATE HIGHWAY 509 OVERPASS, WHICH WAS CLOSED UNTIL FIRE WAS EXTINGUISHED & OVERPASS INSPECTED WITH NO APPARENT STRUCTURAL DAMAGE. A 1/2 MILE EVACUATION WAS INITIATED BY LOCAL FIRE DEPARTMENT AFFECTING APPROX. 40 PEOPLE FROM THIS INDUSTRIAL AREA. PRODUCT IN UTLX 203467 WAS NOT COMPROMISED & WAS LATER TRANSFERRED TO ANOTHER SUITABLE TANK CAR.
