WHILE A 5,000 GALLON CARGO TANK WAS BEING FILLED WITH HYPOCHLORITE SOLUTION, THE DRIVERS SIDE LANDING GEAR LEG GAVE WAY TIPPING THE CARGO TANK OVER ON IT'S SIDE AND SPILLING APPROXIMATELY 2,322 GALLONS OF PRODUCT. ALL SUPPLY VALVES/PUMPS WERE IMMEDIATELY SECURED AND THE MANHOLE COVER ON TOP OF THE TANKER WAS CLOSED. THE AREA WAS FLUSHED WITH WATER FOR APPROXIMATELY FOUR HOURS. TO PREVENT A REOCCURRENCE, A PROCEDURE HAS BEEN IMPLEMENTED WHICH REQUIRED ANY TANKER/TRAILER BEING LOADED OR UNLOADED WITHOUT A POWER UNIT IN PLACE TO HAVE A STABILIZATION JACK IN PLACE.
