DRIVER WAS NORTH BOUND ON THE SOUTHWEST FREEWAY IN HOUSTON, TX WHEN A CAR ENTERED THE FREEWAY FROM THE LEFT LANE AND CROSSED FIVE LANES OF TRAFFIC AT HIGH SPEED, CAUSING A FOUR CAR CHAIN REACTION ACCIDENT. DRIVER STRUCK THE REAR OF A CAR IN FRONT OF HIM. THE IMPACT CAUSED THE WELDS TO FAIL ON 4 OF 6 MOUNTING BOLTS, WHICH LEAKED OIL ONTO THE CONCRETE PAVEMENT. SAND WAS SPREAD ON THE PAVEMENT AFTER THE ACCIDENT TO ABSORB THE OIL AND LATER REMOVED. ALL INJURIES WERE A RESULT OF THE ACCIDENT, NOT FROM CONTACT WITH THE OIL.
