AT APPROXIMATELY 0640 HOURS, SATURDAY, AUGUST 10, 1991 EMPLOYEES WORKING AT THE CONRAIL SELKIRK, NY RAIL YARD OBSERVED VAPOR PRODUCT COMING FROM TANK CAR LCTX-1803 (ARGON, REFRIGERATED LIQUID). A CONRAIL EMPLOYEE INITIALLY SENT TO OBTAIN THE CAR NUMBER OF THE LEAKING TANK CAR OBTAINED, IN ERROR, THE CAR NUMBER OF A TANK CAR CONTAINING LIQUIFIED PETROLEUM GAS. THIS ERROR LED TO THE EVACUATION OF EMPLOYEES IN THE RAIL YARD FOR APPROXIMATELY THREE HOURS. FURTHER PROCEDURES EVENTUALLY IDENTIFIED THE ACTUAL LEAKING TANK CAR AT WHICH TIME THE APPROPRIATE SHIPPER WAS NOTIFIED. RESPONSE PERSONNEL FROM THE SHIPPER (UNION CARBIDE) RESPONDED TO THE LOCATION OF THE CAR AND UPON INSPECTION DISCOVERED A BLOWN 52 POUND RUPTURE DISC IN THE CAR'S SAFETY VENT. A NEW DISK WAS INSERTED THEREBY STOPPING THE ESCAPE OF VAPOR FROM THE CAR. CAR WAS CLEARED TO DESTINATION AT APPROXIMATELY 1500 HOURS, AUGUST 10, 1991.
