ACCORDING TO THE INFORMATION OBTAINED, THE FOLLOWING OCCURRED. WHILE IN THE PROCESS OF MOVING THE PRODUCTS TO A MIXING TANK FOR BLENDING, APPROXIMATELY 540 GALLONS RELEASED. THE LIQUID RELEASED WAS A MIXTURE, WHICH CONSISTED OF 99% POTASSIUM HYDROXIDE SOLUTION AND 1% PHOSPHORIC ACID SOLUTION. THE RELEASE WAS THE RESULT OF AN OPEN VALVE, WHICH AN EMPLOYEE DID NOT CLOSE. THE LIQUID RELEASED INTO A LINED TRENCH, WHICH LEADS TO A SUMP INSIDE OF THE BUILDING. HAWKINS, INC. PERSONNEL PERFORMED THE NECESSARY CLEANUP OF THE SUMP AND WILL COORDINATE DISPOSAL OF THE WASTE GENERATED AS A RESULT OF THE INCIDENT. NO INJURIES OR EXPOSURES WERE RELEASED.
