DRIVER OF #1 EXITED OFF I-80 E/B AT THE MINDEN, IA. EXIT. DRIVER PULLED OVER TO CLEAN MIRRORS. WHEN HE PULLED OVER ONTO SHOULDER HE PULLED OVER TOO FAR AND GOT THE UNIT INTO THE SLOPING DITCH AREA. THE SNOW PLOW WHICH HAD CLEARED THE ROAD HAD CLEARED THE SHOULDER SO THAT A DRIVER COULD NOT TELL WHERE THE SHOULDER ENDED AND THE DITCH BEGINS. THE UNIT STARTED TO GO DOWN THE SLOPE SO THE DRIVER STOOPE THE UNIT. THE DRIVER WAS AT A COMPLETE STOP WHEN THE UNIT ROLLED OVER ONTO IT'S RIGHT SIDE IN THE DITCH. THE #1 COMPARTMENT MECHANICAL VAPOR RECOVERY VALVE OPENED TO A SMALL DEGREE AND LET PRODUCT SEEP INTO THE VAPOR RECOVERY TUBING WHICH RESULTED IN THE RELEASE OF PRODUCT.
