UNIT LOADED AND HAD DEPARTED STAUFFER CHEMICAL COMPANY, BATON ROUGE, LOUISIANA ENROUTE TO DESTINATION, EL DORADO, ARKANSAS. AT APPROXIMATELY 1800 HOURS SOME TWELVE MILES FROM ORIGIN, DRIVER NOTICED VAPORS ESCAPING FROM RELIEF VALVE. DRIVER REQUESTED AID FROM PASSING MOTORIST AND ATTEMPTED TO KEEP PASSER-BYS AND ON-LOOKERS AWAY. LOUISIANA STATE POLICE, DEQ, ZACHARY FIRE AND POLICE DEPARTMENTS, BATON ROUGE FIRE DEPARTMENT, STAUFFER CHEMICAL COMPANY RESPONSE TEAM AND MISSISSIPPI CHEMICAL EXPRESS, INC. EMPLOYEES RESPONDED TO INCIDENT. APPROXIMATELY 5 1/2 HOURS LATER RELIEF VALVE WAS CAPPED OFF AND UNIT RETURNED TO STAUFFER CHEMICAL COMPANY FOR OFF LOADING. A SUBSEQUENT INSPECTION OF TANK REVEALED TWO BAFFLES BROKEN IN TANK AND ONE STRUCK RELIEF VALVE CAUSING VAPORS TO ESCAPE. APPROXIMATELY 53 PEOPLE WERE TREATED AND RELEASED FROM HOSPITAL DUE TO THE INHALATION OF FUMES.
