VMCX 5516 WAS NOTED WITH PRODUCT ODOR IN AREA OF CAR BY CARRIER PERSONNEL DURING INITIAL INSPECTION UPON RECEIPT IN INTERCHANGE FROM THE NEW ORLEANS PUBLIC BELT RAILROAD, WEST YARD TRACK 18. CAR ISOLATED, SHIPPER, AUTHORITIES AND EMERGENCY RESPONSE PERSONNEL WERE NOTIFIED. ENVIRONMENTAL CONTRACTORS, FEDERAL, STATE, AND LOCAL EMERGENCY RESPONDERS AND SHIPPER REPRESENTATIVES RESPONDED AND FOUND MATERIAL ODOR WAS ORIGINATING FROM A VAPOR EDUCATION VALVE. THE ODOR WAS CONTROLLED BY PLACING A CHLORINE C-KIT OVER THE VAPOR VALVE STOPPING THE ODOR RELEASE. THE CAR WAS FORWARDED WITHOUT INCIDENT TO THE SHIPPER'S FACILITY IN GEISMAR, LA, UNDER AUTHORITY OF FRA EMERGENCY EXEMPTION. THE CAR WAS OFF-LOADED AND IS CURRENTLY ON-HAND AT THE SHIPPER'S PLANT AWAITING REMOVAL AND INSPECTION OF THE VAPOR VALVE TO DETERMINE THE EXACT CAUSE OF THE ODOR RELEASE.
