Describe:

UTLX 9511107 was discovered actively leaking from the B-End liquid valve at Roseville Subdivision, Milepost 104.8, Track 207 (Roseville Yard). Upon initial observation, personnel walking past the tank car detected an audible hissing sound, indicating a release of product. A closer inspection by Hazmat Team personnel revealed there was some icing present on the B-End liquid valve body, which was consistent with a product release. The team confirmed that material was leaking from the B-End liquid line. Investigation determined that the B-End liquid valve had been left partially cracked open and the liquid line plug was found to be less than tool-tight, allowing the release to occur. The leak was directly attributed to the failure to properly secure critical components and devices, resulting in the unintended release of hazardous material. Proper closure of the liquid valve and proper tightening of the liquid line plug would have prevented the release.

The shipper must ensure that all valves and secondary closure devices, such as caps and plugs, are secured to tool-tight specifications to maintain package integrity and securement. Although this was a residue car, all valves, plugs, and secondary closure devices are still required to be properly secured in accordance with applicable requirements.
