OUR DRIVER WAS ON BREAK AT THE I-70 MOTOR INN AND WAS ADVISED BY SECURITY AT APPROX. 2030 THAT THERE WAS VAPOR COMING FROM THE TOP OF HIS TRAILER. HE CHECKED AND FOUND THIS TO BE TRUE. HE WAS UNABLE TO STOP THE LEAK AND WAS REQUESTED BY THE AUTHORITIES TO MOVE HIS UNIT APPROX. 200 YDS. FROM THE MOTEL. THE DRIVER NOTIFIED THE COMPANY AND RESPONSE PEOPLE WERE DISPATCHED TO THE SCENE. IT WAS DETERMINED THAT A VALVE HANDLE OF THE TRAILER WAS OUT OF ALIGNMENT ALLOWING PRODUCT INTO THE PIPING AND VAPOR ESCAPED THROUGH A PRESSURE GAUGE ON TOP OF THE TANK. THE TRAILER WAS A SHIPPER OWNED TRAILER AND MAINTAINED BY THE SHIPPER. THE RESPONSE PERSONNEL WERE ABLE TO REPAIR THE TRAILER AND IT WAS THEN RELEASED BY AUTHORITIES AND COMPLETED THE TRIP.
