Portable tank was observed to be leaking or "venting" from a line from a tank level sensor to a level gauge. Ice was beginning to form at the point of the suspected leak. Therefore, we investigating further by chipping away at the ice. It was then confirmed that the leak was indeed at this point. The tank was isolated and the customer was notified. By the time the customer arrived, the leaking pipe was frozen over completely by a large block of ice and the tank level had been reduced significantly. The customer has made arrangements to relocate this tank container to their own facilities for repairs. END
