Describe:

Driver arrived at the designated facility. Driver traveled on a facility owned service road proceeding to scale. The vehicle turnover while making a left hand turn. the debris content in the rolloff bin partially released from the container onto the limestone service road.

The spill was solid debris comprised of steel, concrete, and brick. It was contained to a pile in direct proximity to the rolloff. Affected area was approximately 30x15 rectangle.

The destination facility personnel responded to the release by placing it into a dump truck along with excavated gravel from the road. The facility was the designated landfill to which the load was being delivered. The recovered material was disposed of at the facility.
