INTERNAL BULKHEAD RUPTURED AND GASOLINE LEAKED INTO DOUBLE BULKHEAD COMPARTMENT AND OUT INSPECTION THREADED HOLE. SPILL WAS CONTAINED ON SITE AND ALL SOIL CONTAMINATED REMOVED FROM SITE. PREVENTION FOR FUTURE INCLUDES ADDITIONAL SAFETY TRAINING AND CONTINUING DRIVER EDUCATION.
