On September 29, 2012 at 1012 hours, personnel in the CSXT Selkirk Yard discovered APRX 6011, a loaded tank car of Argon, UN1951, venting continuously from the BL side cabinet. The car was isolated and the shipper, Air Products, was notified via CHEMTREC report number, 20120929-00057, and shipper representative, Michael Tetreaort, 518-522-1148 contacted. A CSXT HazMat Sentinel responded and found the PRD in the BL Side box to be venting continuously, the valve piping frozen over with a heavy coating of ice. The piping was de-iced and the PRD reset. At 1350 hours the tank car was moved to destination under verbal FRA movement approval #20120929R1V for unloading.

This incident did require a special switching move.
