WHILE DOCKWORKER WAS UNLOADING A SHIPMENT OF CYLINDERS FROM TRAILER ONE OF THEM, WHICH CONTAINED NITRIC ACID, ROLLED OFF THE PALLET STRIKING THE GROUND. THE CYLINDER, WHICH ONLY FELL ABOUT SIX INCHES, STARTED LEAKING FROM THE VALVE. THE FACILITY WAS IMMEDIATELY EVACUATED AND EMERGENCY RESPONSE PERSONNEL WERE NOTIFIED. AFTER TAKING AIR SAMPLES NO HAZARD WAS FOUND AND OPERATIONS WERE RESUMED WITHOUT INCIDENT.
