ALL TOTES MUST BE BLOCKED, BRACED, SECURED AND SHROUDED FOR ADEQUATE PROTECTION TO PREVENT EASY DAMAGING. USE LOAD LOCK BARS, STRAPS AND MW PALLETS TO ENSURE LOAD IS SAFE AND SECURE BEFORE MOVING. PAILS, BAGS AND DRUMS OF CHEMICALS MUST BE COMPLETELY SHROUDED USING MW PALLETS, PLYWOOD AND OR DUNNAGE. USING DECK BARS OR LOAD LOCK BARS PROPERLY AND SAFELY TO LOAD FREIGHT ON TOP OF! RETRAINING IN WORK METHODS ON PROPER AND SAFE LOADING OF CHEMICALS. RETRAIN IN HAZARDOUS MATERIALS. WHEN LOADING, SIGNAGE STATING, PAILS OR DRUMS OF LIQUIDS AHEAD. HEAVY FREIGHT LOADED ON THE BOTTOM, LIGHT FREIGHT ON TOP! USE PLENTY OF CUSHIONING BETWEEN LAYERS OF FREIGHT. DISCUSS WITH THE SHIPPER TO MAKE SURE LIDS ON DRUMS ARE SECURED.
