Describe:

Driver had offloaded part of the load from his cargo tank to the customer storage tank. He was going to deliver the remaining product into a different storage tank. As he was setting up, a jack started to fall and as he reached out to grab it with one hand, he accidentally grabbed the external valve which had the transport plug in it with the dog ears latched. When he grabbed it, it unlatched one of the dog ear's and it somehow still had pressure in the cavity which shot the plug off and sprayed out approximately one quart or less of product on drivers face. Driver said he did relieve the pressure in the cavity after the first tank so is unsure why there was still pressure in it. Driver immediately got into an emergency shower until the ambulance arrived. He was taken to the hospital where he was treated and released. On-site personnel said the driver just had safety glasses on.
