AN AMEROCHEM CORP. TRUCK AND TRAILER WAS DELIVERING IN A MOUNTAINOUS AREA OF ROUTE 9, POLK COUNTY, NC, CAME AROUND A CURVE UPON A STALLED PICK-UP TRUCK AND WAS UNABLE TO STOP COMPLETELY OR STEER CLEAR BEFORE STRIKING THE RIGHT REAR CORNER OF THE VEHICLE. THE DRIVER STOPPED THE TRUCK ON THE NARROW STEEP SHOULDER BUT AFTER A FEW SECONDS THE EMBANKMENT GAVE WAY AND THE RIG ROLLED OVER 120 DEGREES DOWN A HILL.

ONE OF A NUMBER OF 330 GAL IBCs WAS CRUSHED BY ANOTHER FULL IBC AND LEAKED ITS CONTENTS FROM A 12 INCH CRACK IN THE SIDE OF THE IBC. A HAZMAT RESPONSE COMPANY (STAT, LENOIR, NC) REMOVED ALL CONTAINERS AND ALL CONTAMINATED SOIL. NO ENVIRONMENTAL DAMAGE EXPECTED.
