Describe:

Driver was traveling on Highway 178 east going up mountain when a bolder fell into the roadway. Driver moved over to the right to avoid hitting the bolder. When he did he scrape the rock wall to his right with the trailer he was pulling. The rock put a 2 inch crack in the outer shell on the right rear side causing the trailer to loose pressure. The California Highway Patrol closed the roadway and the Kern's County Fire Department was dispatched to the scene. Another unit was brought to the scene, and the load was pumped off into. The amount of time the release took place until the load was completely transfer was approximately 5 hours.
